

#### Tax collection at Nendaz

#### A Practical guide

According to the Tourism Law, the tourist tax should finance "the operation of an information and reservation service, local events, and the creation, the development and operation of sports, cultural or touristic infrastructure."

### MORE SPECIFICALLY, AT NENDAZ IT FINANCES:

- Information services (information desk, website, brochures) and events managed by Nendaz Tourisme (weekly activities, events and shows)
- Contribution to touristic, cultural and sports infrastructure including the Sports Centre, the swimming pool and tennis
- The development of services for guests and owners of secondary residencies: free shuttle buses during the winter, free Wi-fi at the resort, owner days, owner benefits, extended ski lift opening hours etc



#### MUNICIPAL TAXES

## (DRINKING WATER, WATER TREATMENT, AND WASTE REMOVAL)

- Drinking water and water treatment: taxes depend on the number of connection points (basic tax) and the water consumption measured using a water meter that is invoiced for each dwelling or to the building management.
- Waste removal: the basic tax is calculated for each dwelling in line with the gross surface area of the habitable floor space.
- **Use of taxes:** finances infrastructure maintenance and improvement (pipes, waste collection points).

#### ANNUAL TOURIST TAXE

- **Flat-fee tourist tax:** calculated in line with the tourist tax amount per overnight stay, average occupation rate, dwelling category, and location.
- Tourist tax per overnight stay: for medium/long-term rentals, the renter can request a named fee via email using this email address: <a href="mailto:tsinfo@nendaz.org">tsinfo@nendaz.org</a>. Owners must declare overnight stays using the form available online at <a href="https://www.nendaz.org">www.nendaz.org</a>.
- **Use of taxes:** finances information and welcome services as well as events and the set-up and operation of sporting, cultural or touristic infrastructure.

#### RENTER TOURIST PROMOTION TAX (renter TPT)

- Flat-rate fee calculated in line with the number of rooms in a dwelling (the stay + bedrooms).
- Invoicing to owners who have rented out their accommodation during the year in line with declarations received. Available online at <a href="https://www.nendaz.org">www.nendaz.org</a>
- Invoiced to owners who have rented out their dwelling during the year.
- Use of taxes: finances promotion, marketing and sponsoring of Nendaz Tourisme,
